TERMS AND CONDITIONS OF PARTICIPATION

"12 Faces of the Kitchen" (version: July 2025)

1. GENERAL PROVISIONS

- 1.1. These Terms and Conditions (hereinafter: "Terms") govern the participation in the competition "12 Faces of the Kitchen" (hereinafter: "Competition"), organized by Second Opinion GmbH, Tuchlauben 7a, 1010 Vienna, Austria (hereinafter: "Organizer").

- 2.4. Each application must include:
- one photograph,
- one recipe of a local dish,
- one written story about the institution.
- 2.5. Applications must be submitted via the official online application form within the defined time frame.

3. PARTICIPANT OBLIGATIONS

- 3.1. The participant guarantees that all submitted content is original and does not infringe on the rights of third parties.
- 3.2. The participant is responsible for obtaining the written consent of any person appearing in submitted photographs.

- 3.3. The participant bears full responsibility for the truthfulness and lawfulness of the submitted materials.
- 3.4. All required documents (authorship declaration, consent forms) must be submitted in the prescribed format.

4. RIGHTS AND OBLIGATIONS OF THE ORGANIZER

- 4.1. The Organizer reserves the right to verify the validity of entries and request additional documentation where needed.
- 4.2. The Organizer may reject applications that are incomplete, inappropriate, or in violation of these Terms.
- 4.3. The Organizer may change, suspend, or cancel the Competition due to force majeure, technical issues, or justified circumstances.

5. INTELLECTUAL PROPERTY

- 5.1. Participants retain authorship of their work but grant the Organizer a non-exclusive, unlimited right to use the submitted materials for promotional, educational, and informational purposes.
- 5.2. Use includes publication on the website, social media, in printed and digital formats, exhibitions, and calendars.

6. DATA PROTECTION

- 6.1. The Organizer processes personal data solely for the purposes of running and promoting the Competition, in accordance with Regulation (EU) 2016/679 (GDPR).
